DESCRIPTION

Sovereign AquaJect Super Concentrate is a water-based concentrate specifically formulated as a chemical damp proof course (DPC) injection fluid. It is a true solution of siloxane in water, and when used as directed in accordance with specifications, will match the performance of solvent-based systems and successfully create an effective chemical DPC. On injection into masonry, the siloxane will react with the atmosphere to form a water-insoluble, water-resistant treatment within 24 hours of application.

Once Sovereign AquaJect Super Concentrate has chemically reacted it is permanently fixed by a cross linking action within the substrate pores to form a water-resistant barrier. However, although Sovereign AquaJect Super Concentrate controls the passage of rising damp, it is not a vapour barrier and will still allow the wall to breathe.

Once diluted, Sovereign AquaJect Super Concentrate is non-hazardous, containing no solvents and of low alkalinity. The potential problem of persistent odour related to solvent-based DPC fluids is completely eliminated.

- 4" brick 15 linear metres per 25 litres (diluted product)
- 9" brick 7.5 linear metres per 25 litres (diluted product)
- 13" brick 5.2 linear metres per 25 litres (diluted product) (depending on substrate texture, porosity & application technique)

PREPARATION

- Thoroughly prepare the areas for treatment in accordance with specifications.
- Remove internal skirting boards and damp/salt contaminated plaster to at least 1m above the DPC line, or 300mm beyond the last signs of damp/salt, whichever is the highest.
- At the appropriate height/level, holes should be drilled into the brick not more than 150mm apart, and typically 2 holes per stretcher and 1 per header, at equally spaced centres.
- Best results are obtained if holes are drilled at a slight downward angle, 10° to 15°. Alternatively, holes can be drilled into suitably sound mortar bed joints.

APPLICATION

- Shake well before use.
- Ensure the injection pump has been thoroughly washed out prior to using Sovereign AquaJect Super Concentrate, especially if solvent-based fluids have previously been used.
- Add one 700ml bottle of Sovereign AquaJect Super Concentrate to 24.3 litres clean tap water and mix the solution. Run the pump for 2 to 3 minutes to ensure it is thoroughly mixed. Always add Sovereign AquaJect Super Concentrate to water, never add the other way round.
- New brickwork or mortar is highly alkaline and the normal delay period for injection fluids may be six months. However, this delay can be reduced to two months if Sovereign AquaJect Super Concentrate is used.
- Any remaining concentrate or diluted material must be stored in airtight containers.

CLEANING

• Clean tools and equipment with water immediately after use. Immediately remove spills and splashes.

STORAGE

• Store and transport securely in an upright position. Ensure the cap is secure. Store for up to 12 months from date of manufacture in original, unopened packaging in cool, dry conditions within the temperature range +5°C to +25°C and out of direct sunlight. Protect from frost. Diluted material is stable for up to 6 months when kept in airtight containers.
