IMPORTANT: Before using EVO-STIK Sticks Like Sh*t Turbo refer to the relevant Health & Safety Data Sheet, available at www.bostik.co.uk.

PREPARATION

- Surfaces must be sound, clean and free from contaminants such as dust, oil, grease and any loose material.
- Cut off the dome at the top of the cartridge taking care not to damage the thread. Cut the nozzle at a 45° angle to the required diameter and screw onto the cartridge.
- Insert the cartridge into a cartridge gun and repeatedly squeeze the trigger until the adhesive appears.

APPLICATION

- Always tool using a spatula of stick wetted with water within 5 mins of application.
- 5. Beads 5mm in diameter are generally sufficient.

CLEANING

6. Uncured product can be removed with water
