## USES

Bostik Pave Seal (formerly known as Cementone Pave Seal) is a clear, low viscosity, solvent based acrylic solution that penetrates deeply into dry concrete, brick, porous tiles etc. Bostik Pave Seal provides excellent resistance to water and dirt. It also enhances the colour of the treated surface.

Bostik Pave Seal is suitable for use to protect drives, paths, patios and other porous exterior paved surfaces.

## DIRECTIONS FOR USE

IMPORTANT: Before using Bostik Pave Seal refer to the relevant Health & Safety Data Sheet, available at www.bostik.co.uk.

#### PREPARATION

- 1. Protective gloves and eye/face protection should be worn
- 2. Ensure the surface is clean, dry and free from oil, grease, loose materials and moss.
- 3. Ensure the concrete, brick or tiles are porous and dry internally.
- 4. Remove any efflorescence from concrete surfaces using Bostik Mortar & Brick Cleaner, as directed. Rinse thoroughly and allow to through dry, not just at the surface.
- 5. Do not use Bostik Pave Seal on new concrete, allow at least 28 days after laying.
- 6. Do not apply Bostik Pave Seal onto non-porous materials e.g. quarry tiles, some dense bricks etc.

- 7. Do not use Bostik Pave Seal around swimming pools.
- 8. Always test on a small inconspicuous area and allow to dry prior to full application to safeguard against unwanted changes of appearance to surfaces.
- 9. Protect adjacent surfaces, ponds and plants from splashing.
- 10. Shake well before use.

## APPLICATION

- 11. Bostik Pave Seal must only be applied to dry exterior surfaces above ground. Do not apply in wet or frosty conditions.
- 12. Apply evenly using a soft brush, roller or spray.
- 13. Work into surface. Do not allow to pool on surface.
- 14. After 2 3 hours apply second coat.
- 15. A third coat may be required on very porous surfaces.
- 16. Protect freshly applied product from rain and frost until dry.
- 17. Leave surfaces to dry completely before use, approx. 4 hours for foot traffic, approx. 24 hours for vehicular traffic.

#### CLEANING

- Clean tools and equipment immediately after use with white spirit.
- 19. Dried product is difficult to remove.

#### **PRECAUTIONS IN USE**

Do not apply Bostik Pave Seal in wet or frosty conditions, or if rain is expected. Do not use on new concrete – allow at least 28 days after laying. Do not apply to non-porous materials e.g. quarry tiles, wet moulded concrete slabs and some dense bricks etc. Do not use around swimming pools. Bostik Pave Seal should not be used internally or in enclosed areas where the lingering odour of solvent may be a problem. Efflorescence may still occur after application of Bostik Pave Seal, if the blocks are laid direct onto the ground.
