#### PREPARATION

 Ensure that tiles are firmly fixed and adhesive is completely set. Bostik standard set adhesives should normally be left for at least 24 hours before grouting. Bostik rapid setting adhesives should be left for at least

2 to 3 hours, times will be increased by sealed or impervious substrates or at low ambient temperatures or high humidity.

- 2. Ensure tile and joints are clean, dry and free from dust, grease or any other contamination. Some tiles have a soft glaze which may be scratched during grouting and tiles with a matte or porous texture may be prone to staining. You are advised to test the grout on a spare tile for suitability before proceeding.
- 3. Variations in raw materials, application techniques, type of tile, substrate and environmental conditions can limit colour consistency. For these reasons as with all other manufacturer's we cannot guarantee a consistent colour every time.

#### Underfloor Heating with Ceramic Tiles:

4. Turn off underfloor heating for at least 48 hours before tiling and do not switch back on until 28 days after tiles have been grouted. Thereafter only gradually increase the temperature by 5°C per day.

#### MIXING

- Bostik J115 Flexible Smooth Finish Grout should be added to water in a clean container whilst mechanically stirring and mixing thoroughly to give a smooth, consistent and easily worked mortar.
- The recommended mix proportions are approximately
  0.3 0.4 litres of water to 1kg of Bostik J115 Flexible
  Smooth Finish Grout.
- 7. Do not add more water than is necessary to achieve a smooth paste consistency and do not mix more than can be applied and finished off within a 2hours.
- 8. It is favourable to allow the mixture to stand for 1 minute before use.
- 9. No water should be added after the original mixing.
- 10. Any of the mix that is not used within 2 hours of mixing should be discarded.
- 11. Bostik J115 Flexible Smooth Finish Grout will remain readily workable for about 2 hours with initial setting after 30 minutes when applied in the grout line.

## COVERAGE

Coverage is dependent upon tile size and joint dimensions. It can be calculated using the formula below:

C = Joint width

B = Tile width

A = Tile length

D = Joint depth	G = Specific Gravity

### APPLICATION

- 12. The grout should be worked deeply into the joints using a sponge, squeegee or rubber filling knife. Work diagonally from lower parts upwards. Ideally should not be applied at temperatures below 5°C.
- 13. Remove excess grout immediately by the use of a squeegee, working diagonally across the tiles taking care not to drag grout out of the joints. After initial hardening (approx. 30 minutes) clean the tile surface with a damp sponge. Do not leave film on the surfaces of tiles as this will be very difficult to remove when hardened.
- 14. When the grout is dry, polish the tiles with a clean, dry cloth.

## CLEANING

- 15. Clean tools and equipment immediately after use with water.
- 16. Dispose of all waste material and empty packaging in accordance with local regulations.
