## **PREPARATION**

- It is strongly recommended to wear safety Gloves and Safety Goggles when using this product.
- 2. Stir can before application. Stir frequently during use.
- 3. Substrates must be matured, sound clean and dry.

# **APPLICATION**

- 4. Stir well ensuring any settlement is incorporated.
- 5. Apply using a soft sweeping brush, Paintbrush,
  - Paint rollers are the most economical in labour and consumption of product.
- 6. Avoid excessive working of Bostik Rito Silvershield as this can reduce the brilliance of the finish.



- Apply 2 Coats: The second coat is applied as soon as the first coat is dry.
- 8. Allow 24 hours before foot traffic.

Do Not apply when rain, frost or overnight dew is expected before the coating is completely dry, as bronzing of the surface may result.
