## USES

Bostik Pave Seal (formerly known as Cementone Pave Seal) is a clear, low viscosity, solvent-based acrylic solution that penetrates deeply into dry, porous external paving such as concrete, brick and porous tiles. It provides excellent resistance to water, oil, petrol, grease and dirt. It is clear in colour, but may enhance the colour of the treated surface.

Bostik Pave Seal is suitable for use to protect drives, paths, patios and other porous exterior paved surfaces.

Storage/Shelf Life	Store and transport securely in an upright position. Ensure the cap is fully closed. Store for up to 24 months from date of manufacture in original, unopened packaging in cool, dry conditions within the temperature range +5°C to +25°C and out of direct sunlight and away from heat and sources of ignition. Protect from frost.

#### DIRECTIONS FOR USE

IMPORTANT: Before using Bostik Pave Seal, refer to the relevant Health & Safety Data Sheet, available at www.bostik.com/uk.

#### PREPARATION

- 1. Wear protective gloves and eye/face protection.
- 2. Ensure the surface is clean, dry and free from oil, grease, loose materials and moss. Do not use detergents to wash surface.
- 3. Do not apply in wet or frosty conditions. Work must be carried out in dry weather.
- 4. Allow surfaces to dry for 48 hours before application.
- 5. Remove any efflorescence from concrete surfaces using Bostik Brick & Patio Cleaner, as directed. Rinse thoroughly and allow to through dry, not just at the surface.

- 6. New cement-based surfaces should be allowed to cure for at least 28 days after laying before application.
- Always test on a small inconspicuous area first and allow to fully dry before proceeding to full application. The test area should be examined after 24 hours to safeguard against any unwanted changes of appearance to surfaces.
- 8. Always cover windows and window frames and protect surrounding areas, ponds and plants with plastic sheeting during use.

#### APPLICATION

- 9. Due to the solvented content, do not apply indoors. Do not thin or dilute. Do not apply to non-porous materials e.g. quarry tiles, some dense bricks etc. or to natural stone. Do not use around swimming pools.
- 10. Shake well before use.
- Bostik Pave Seal must only be applied to dry, porous, exterior surfaces, which are above ground level. If applied to wet or non-porous surfaces it will leave a white deposit, which is very difficult to remove.
- 12. Ensure there is good ventilation prior to use.
- 13. Do not apply in very cold or wet conditions.
- 14. Animals and children must be kept away from the treatment area during application and until the area is completely dry and free of any residual product.
- 15. Apply evenly using a soft brush, roller or spray.
- 16. Work into surface, but do not allow to pool.
- 17. After 2 3 hours, apply second coat.
- 18. A third coat may be required on very porous surfaces.
- 19. Protect freshly applied product from rain and frost until dry.
- 20. Leave the surface to dry completely before using; this will be approximately 4 hours for foot traffic and 24 hours for vehicular traffic depending on ambient conditions and the number of coats.

#### CLEANING

- 21. Clean tools and equipment immediately after use with white spirit.
- 22. Dried product is difficult to remove.
- Bostik Pave Seal provides excellent resistance to oil and petrol; however, any spillages must be cleaned up as soon as possible.

#### **PRECAUTIONS IN USE**

Do not apply Bostik Pave Seal in wet or frosty conditions, or if rain is expected.

Do not use on new concrete – allow at least 28 days after laying. Do not apply to non-porous materials e.g. quarry

tiles, wet moulded concrete slabs and some dense bricks etc. or to natural stone.

Do not use around swimming pools.

Bostik Pave Seal must not be used internally or in enclosed areas where the lingering odour of solvent may be a problem.

Efflorescence may still occur after application of Bostik Pave Seal, if the blocks are laid directly onto the ground.
