#### **USES**

Bostik Black Limestone Restorer is a clear liquid, which penetrates into dry, porous, external black limestone paving to return it to a black, matt satin finish.

Black Limestone Restorer reacts with the substrate to form a hard, durable seal, enabling superior performance. The sealer provides excellent resistance to stains and water, while enhancing the paving colour to give a deep black finish. It can be used to protect drives, paths and patios made from black limestone. Black Limestone Restorer can be used on other natural stone, brick or concrete paving, where it will enhance the natural colour. Not for internal use.

#### **DIRECTIONS FOR USE**

## **PREPARATION**

- Ensure the surface is clean, dry and free from dust, dirt, oil, grease, algae, efflorescence, loose materials and moss. For external use only.
- If detergents are used to clean surfaces before applying Black Limestone Restorer, ensure the detergent has been thoroughly washed away, ideally with a pressure washer. Cleaners can leave a detergent film on surfaces, which makes them impermeable, particularly if cleaned during warm weather.
- 3. Black Limestone Restorer must not be used on surfaces that have previously been treated with a sealer, are polished or honed. Surfaces must be porous.

- 4. Do not apply in wet or frosty conditions, or direct sunlight. Work must be carried out in dry weather within the temperature range +10°C to +20°C. Ensure the surface of the paving is cool to touch.
- 5. Allow surfaces to dry for 24 hours before application.
- 6. Always test on a small inconspicuous area first and allow to fully dry before proceeding to full application. The test area should be examined after 48 hours of normal use to ensure compatibility, performance, ensure that the paving is not slippery and safeguard against any unwanted changes of appearance or texture to surfaces.
- 7. Always cover surrounding areas, ponds and plants with plastic sheeting during use.

#### **APPLICATION**

- 8. Shake well before use. Do not dilute. Do not apply to non-porous materials e.g. quarry tiles, engineering bricks, polished or glazed stone.
- Black Limestone Restorer must only be applied to dry, porous, exterior surfaces, which are above ground level. If applied to wet or non-porous surfaces it will leave a white deposit, which is very difficult to remove. Ensure footwear is clean to avoid contamination and footprints on substrates.
- 10. Animals and children must be kept away from the treatment area during application and until the area is completely dry and free of any residual product.
- 11. Do not pour directly onto paving. Using a paint pad, apply an even, thin coat to one paver at a time. Continue coverage up to the joints. Do not allow to pool.
- 12. IMPORTANT: After applying to one paver, immediately wipe the surface with a rag or lint free cloth to remove excess product. If this is not completed, the final surface will be have a gloss look and be slippery.
- 13. For very porous surfaces, apply a second coat within 20 minutes of the first, again immediately removing excess product.
- 14. Protect freshly applied product from rain and frost until fully dry (approx. 12 hours).
- 15. Leave the surface to dry completely before using; this will be approximately 12 hours for light foot traffic and 24 hours for vehicular traffic, depending on ambient conditions and the number of coats. Optimal performance is achieved after 7 days. Cooler weather will increase the curing time.

## **CLEANING**

- 16. Clean tools and equipment with white spirit immediately after use. Dried product is difficult to remove.
- 17. Black Limestone Restorer helps resist staining, however, any spillages onto limestone must still be cleaned up as soon as possible.

#### **PRECAUTIONS IN USE**

Do not use internally, or around swimming pools. Efflorescence may still occur after application of Black Limestone Restorer, if the blocks are laid directly onto the ground.

Do not use acid cleaners to clean the paving once Black Limestone Restorer has been applied.
