USES

Bostik STIX A550 POWER ELASTIC is a versatile, premium acrylic adhesive suitable for a wide variety of floor coverings. The solvent-free formulation has a low odour and very low VOC emissions (EC1 Plus), and is ideal for many uses including conservatories and atriums. It has been specially formulated to give high performance over a large temperature range and offers exceptional plasticiser migration resistance.

It is suitable for interior use with a wide range of soft floor coverings, including LVT in planks or tiles, rubber flooring (max 4mm)*, linoleums, all PVC sheet and tile products, expanded and blown vinyl, all types of carpet, natural fibres (coco, sisal & sea grass), semi-rigid PVC tiles, and floor coverings with dimensional variation and shape.

*Always check with rubber flooring manufactures to ensure acrylic type adhesives are recommended with their specific product.

PREPARATION

Subfloor:

- 1. Ensure the subfloor is clean, sound, dry and free from contaminants that may hinder adhesion.
- The subfloor should be tested in accordance with British Standards using a properly calibrated and insulated hygrometer.
- 3. A reading of 75% RH or less confirms that the subfloor is satisfactorily dry. Where this has not been attained, it is necessary to apply a Bostik Screedmaster surface membrane to suppress residual moisture. For further information, contact Technical Services.
- 4. If any areas of the subfloor are in need of localised repairs, use Bostik Screedmaster Rapid Repair Mortar.
- 5. For subfloors that are not sufficiently smooth or absorbent, or require height build up to receive the particular floor covering being bonded, an application of a suitable Bostik Screedmaster smoothing compound and primer system is recommended. Please consult Technical Services for advice on specific products and subfloors.
- 6. Very absorbent subfloors such as open textured screeds and plywood should be primed prior to applying adhesive, with a suitable Bostik primer. Allow the primer to fully dry.
- 7. Priming reduces over-absorption of the adhesive into the substrate, giving a good working time and strong adhesive bond.
- 8. Before applying any adhesive, ensure the substrate is dry and dust free.

APPLICATION PROCESS

- Select appropriate trowel size and application method for the floor covering and apply the adhesive evenly onto the subfloor, holding the trowel at an angle of 60°.
- 10. Avoid pooling of the adhesive during application.

- 11. Lay floor covering while the adhesive is wet/semi wet to ensure transfer and enable adhesive ribs to be compressed.
- 12. Bond the floor covering by applying pressure with a clean roller, ensuring air is not entrained or trapped under the flooring. Repeat after 30 to 45 minutes to consolidate the bond.
- 13. Do not weld the joints before the adhesive has had sufficient time to develop a good bond (approx. 24 hours after installation).
- 14. Room conditions must be maintained for 24 hours while the adhesive fully cures.

CLEANING

15. Clean tools and equipment with warm water immediately after use. Remove any adhesive from the surface of the floor covering with a damp cloth.
