#### USES

Bostik Cempolatex Moisture Suppressant is a ready for use; one part, water-based moisture suppressant membrane. Developed to suppress residual construction moisture in cementitious subfloors including power floated concrete and sand/cement screeds.

Two coats will provide protection up to a maximum hygrometer reading of 95% RH.

#### **DIRECTIONS FOR USE**

IMPORTANT: Before using Bostik Cempolatex Moisture Suppressant, refer to the relevant Health and Safety Data Sheet, available at www.bostik.com/uk.

#### PREPARATION

- 1. Ensure the subfloor is clean, sound, surface dry and free from dust or any other contaminants that may prevent adhesion. Remove all surface water.
- 2. Highly polished surfaces or concrete containing a curing agent or surface hardener may require shot blasting.
- 3. Power floated concrete must be abraded or shot blasted to provide a good key for adhesion.

#### APPLICATION

- 4. Shake the bottle to mix contents immediately prior to use. Bostik Cempolatex Moisture Suppressant must be applied in two coats.
- 5. First coat: pre-wet a roller in the Bostik Cempolatex Moisture Suppressant. Apply the first coat in one direction ensuring that the material is worked well into the substrate. Wait until touch dry before applying the second coat in a direction at right angles to the first coat.

- 6. Second coat: when the first coat is touch dry, approximately 15 to 30 minutes at 20°C, apply the second coat in a direction at right angles to the first coat. It is essential that a pin-hole free coating is achieved and to maintain a coverage rate of 20m<sup>2</sup> per 2.5L per coat, i.e. 5L unit covers 20m<sup>2</sup> at 2 coats.
- 7. Allow to dry to a tack-free film. At 20°C the drying time will be approximately 1 hour.
- 8. Cover with a minimum 3mm thickness of a Bostik Cempolatex smoothing compound to provide an absorption medium for any subsequent adhesive or as a level for any floor covering.
- 9. Bostik Cempolatex Moisture Suppressant should not be trafficked between coats and before the smoothing compound is applied.

#### CLEANING

10. Clean tools and equipment immediately after use with water or white spirit if the product has dried.
