BOSTIK INTUSTRIP SEALANT INTUMESCENT PRE-FORMED GLAZING STRIP

Bostik Intustrip is a soft adhesive pre-formed strip sealant developed for use as a compression seal in fire sensitive situations. The strip is based on a hydrocarbon rubber, compounded with special additives which cause the product to swell (intumesce) when exposed to flame or other heat source, the insulating char formed being resistant to the passage of smoke and flames. Bostik Intustrip is supplied on reels ensuring that the product is easy and economical in use. Bostik Intustrip can be used in the bedding of glass in window frames and doors, and in compression seals.

When used for its intended purpose does not detract from the surface spread of flame characteristics of the duct work.

Longer fire ratings are possible depending on the type of glass, frame, bead and fixings.

Directions for use

IMPORTANT

Before embarking on any work involving Bostik Intustrip, the separate Safety Data Sheet should be carefully studied by those carrying out the work.

- 1. All surfaces must be sound, clean, dry and free from oil, grease, dust and other loose materials.
- 2. Unreel the strip, taking care not to stretch it. Single strips can be made by running a sharp blade between the strip while it is still on the roll. The advantage of a single strip is that it can be placed before the release paper is removed thus preventing stretching.
- 3. Lay the strip on or against one of the joint sides during assembly.
- 4. A) GLAZING Place the strip around the glazing rebate and bed the glass in position. Bed the glazing beads similarly on additional strips of Bostik Intustrip prior to fixing them using screws of at least 50mm in length.

B) COMPRESSION SEALS Lay the strip on one side of the flange and then assemble the flange joint, ensuring uniform compression of the strip as the joint is mechanically closed.
