#### **DESCRIPTION**

Bostik's TOTALPrime™ is a ready-to-use, polymer-based primer designed for a variety of challenging substrates. TOTALPrime™ tenaciously bonds to non-porous substrates, like epoxy coatings and existing tiles. The bond-enhancing sand suspended in the formulation imparts superior mechanical adhesion. TOTALPrime™ provides a coarse textured surface ideal for enhancing the bond of mortars, self-leveling underlayment and patches, ensuring excellent adhesion even on challenging substrates, see chart.

# **DIRECTIONS FOR USE**

Read and understand technical and safety data sheets completely before beginning installation. All tile applications over TOTAL Prime  $^{\rm TM}$  must follow applicable ANSI, NTCA and TCNA installation standards. Refer to www.bostik.com/us for the most recent product information and safety data sheet prior to installation.

#### **LEED CONTRIBUTION**

This low VOC formulation (as calculated per SCAQMD Rule 1113) may contribute toward LEED v4 IEQ Credit - Low-Emitting Materials for Coatings.

## **MIXING**

If settling occurs, stir prior to use. Do not entrain air into the product when stirring.



#### **SURFACE PREPARATION**

**GENERAL NOTE:** TOTALPrime™ is not a vapor barrier. Test substrate as per ASTM F-1869 for (MVER) and/or ASTM F-2170 for RH%. MVER should not exceed 5lbs per 1,000 sq. ft. per 24 hours according to ASTM F1869 test method (Calcium Chloride Test), and/or 75% RH per ASTM F2170 test method. If levels exceed those permissible by any component in the flooring system, apply a Bostik moisture vapor barrier coating (i.e. Bostik Slab-Cote™ or D-250™), allow to properly cure and then apply Bostik TOTALPrime™.

All surfaces mus t be clean, sound, dry, 50°F (10°C) and free of oil, wax, grease, sealers and/or curing compounds, urethane, paint, asphalt, loose surface material or any contaminate that will act as a bond breaker. Never use mastic removers on any surface to which a Bostik product will be applied. If sealers and/ or curing compounds are present they must be removed by mechanical means prior to application.

TOTALPrime™, when used with a waterproofing and crack isolation membrane, must have a cementitious patch or self leveling underlayment over the surface prior to the application of the waterproofing and crack isolation membrane. Refer to the data sheet of the Bostik cement based product being installed. Follow the specific substrate preparation, priming, mixing and application guidelines. Adhere to all product limitations and if unsure about a particular application, contact Bostik Technical Service.

NOTE: It is the user's responsibility to determine the condition and suitability of all surfaces before application.

#### **LIMITATIONS**

- Do not dilute.
- · Do not allow to freeze.
- MVER should not exceed 5lbs per 1,000 sq. ft. per 24 hours according to ASTM F1869 test method (Calcium Chloride Test), and/or 75% RH per ASTM F2170 test method.
- Concrete must be cured, free of efflorescence, and not be subject to hydrostatic pressure.
- TOTALPrime™ should be re-applied if allowed to dry for more than 72 hours.
- For low temperatures, damp or humid environments, additional drying time may be required.
- · Not for use over poured gypsum concrete, such as "Gypcrete"
- TOTALPrime™ is primarily designed for interior use. TOTALPrime™
  may be used for exterior applications, contact Bostik technical
  service for further information and approved applications.
- · Not for submerged applications.
- · Leave no bare spots or puddles of overapplied product.
- Adequate ventilation should be provided for uniform drying and temperature must be maintained between 50°F - 95°F (10°C - 35°C).

# **CLEAN UP**

Clean tools with water immediately after use or by mechanical means once dry. Protect surrounding surfaces from exposure as TOTALPrime™ is extremely difficult to remove when dry.

## STORAGE AND SHELF LIFE

Store in cooldry area ( $50^{\circ}F - 95^{\circ}F/10^{\circ}C - 35^{\circ}C$ ). Tightly seal package and do not expose to sun. Shelf life is 2 years. **DO NOT FREEZE.**
