DESCRIPTION

Timber Set is a high solids, water based latex adhesive that dries to form a strong bond between timber substrates.

Timber Set is specially formulated for adhering mosaic, or timber veneer to timber substrates.

APPLICATION INSTRUCTIONS

Ensure all timber substrates are clean, dry, smooth, free from dirt, wax, oil and any coatings or adhesives.

Apply adhesive onto the surface using a 3mm x 3mm V notched spreader. Spread only about 1 square metre at a time to ensure 100% adhesive transfer to the timber.

MIXINO

No mixing is required, simply use directly from pail.

PRECAUTION

Timber Set is not recommended for installing any timber flooring over concrete, this application should be carried out with Bostik Ultraset (refer technical bulletin).

Do not apply below 10°C or above 35°C. Ensure the substrate is porous to enable **Timber Set** to achieve sufficient bond. Do not apply over existing coatings as bond will be affected.

CLEAN-UP

Clean up uncured material and equipment immediately after use with water or Bostik-Handi clean towels.

COVERAGE

Approximately 0.8 - 1m2 / litre depending on substrate conditions

HEALTH AND SAFETY

- On contact, uncured adhesive may cause irritation.
- Gloves and protective goggles must be worn during application and use.
- Avoid contact with skin, eyes and avoid breathing in vapour
- Wear protective gloves when mixing or using
