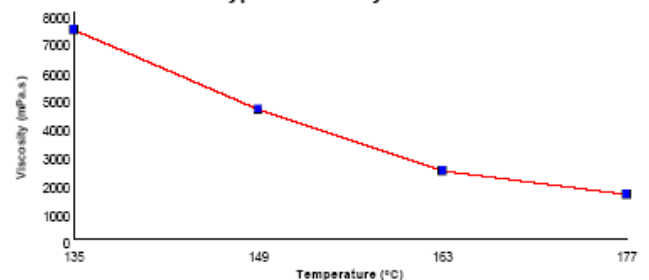
DIRECTIONS FOR USE

- 1) Applied via spray, swirl spray, bead or roller using a hot melt applicator machine.
- 2) Suggested application temperature range is 130°C to 190°C.
- 3) Apply the adhesive to one surface to be bonded.
- 4) Immediately carefully align the second substrate and combine with firm hand pressure.
