## **POLYOLEFIN WEB ADHESIVE**

#### **KEY FEATURES**

- Moderate heat activation temperature
- Soft hand feel

## **DESCRIPTION**

Bostik PO102 is a hot melt adhesive produced in nonwoven form. Made in a fine filament pattern, PO102 offers uniform adhesive coverage. Produced in roll form, this web is suitable for both intermittent and continuous processes. Potential applications of this web adhesive include footwear laminates, apparel laminates, filter assembly and foam-to-fabric bonding. The moderate melt and fast setting characteristics of the PO102 make it ideally suited for temperature sensitive substrates. PO102 has a soft hand feel and good elongation but has more durability than some lower melt PO webs. PO102 has good adhesion to polyethylene nonwovens and contoured polyester fabrics.

## **PACKAGING**

PO102 web is sold in roll form. They are typically 500 to 1000 linear yard (457 to 914 linear meter) long rolls on a 3 inch (7.6 cm) inner diameter core. For further packaging details, please contact your Bostik representative.

#### **SHELF LIFE**

The shelf life of PO102 is approximately 365 days.

#### **STORAGE & HANDLING**

Bostik recommends storing PO102 web at temperatures less than 130°F (54°C).

## **APPLICATION TECHNIQUES**

Bostik PO102 web can be activated with any of the following techniques: Electric fusing press, heated rolls, heated air or radiant heat. Dry heat activation requires  $234^{\circ}F$  ( $112^{\circ}C$ ).

Reactivation time is dependent upon technique, temperature, pressure, substrates and adhesive thickness, but would fall in the 8 to 10 second range.
